It is located on the M2 line between Ryparken and Frederiksberg. The issues which appellant attempts to present to this court are set forth in a manner which does not comply with the proper briefing requirements of Ind.R.Ap.P. 8.3. Upon review of appellant's brief, this court finds that appellant presents a case involving only a "mixed of law and fact," i.e. whether or not the Indiana statute governing the tampering with a witness applies to only the phrase "tamper" or, that phrase applies to all three specific elements of the crime of witness tampering, i.e. corruptly tamper with any person, or force, or threaten, or offer any favor to any person. Appellant does not present a "purely legal" issue, i.e. whether or not the crime of witness tampering is a Class D felony where the victim does not fear for his
